



Installation Instructions for **HOT POT™** Stainless Food Warmer

In just a few minutes, your sled will really cook!

Here's all you have to do to get your HOT POT™ installed on your sled in just minutes!

- 1 Remove the HOT POT™ from the aluminum mounting base.
- 2 Open the HOT POT™ and remove the stainless steel clamp.
- 3 For optimal heat transfer, the aluminum mounting base should be installed so that it directly contacts the exhaust pipe. On most snowmobiles it is best to install the mounting plate where the pipe bends several inches after coming out of the exhaust port (refer to photo for proper placement).
- 4 On many snowmobiles the OEM exhaust pipe has an aluminum shroud. To shorten the cooking times, you may want to remove and carefully cut out a piece of the exhaust shroud to allow the mounting base to come in direct contact with the pipe.
- 5 Using a standard screwdriver, fasten the aluminum mounting plate to the exhaust pipe with the stainless steel clamp.
- 6 Using spring clips, fasten HOT POT™ to mounting base.
- 7 Carefully lower the hood of your snowmobile to ensure proper clearance. You should install HOT POT with a minimum of 3/4" to 1" clearance to the hood.
IMPORTANT: If the HOT POT™ touches the hood of your snowmobile it may discolor or distort your bodywork! If this is the case, loosen the mounting clamp and rotate or relocate mounting base to allow hood to close properly with 3/4" to 1" clearance.
- 8 You're ready to go!



CAUTION-HEALTH HAZARD!

NEVER use your HOT POT™ to prepare uncooked foods.

If you try to cook raw meats such as chicken or beef or others you may not reach temperatures hot enough or long enough to kill bacteria such as e-coli, salmonella and others which may lead to food-borne illnesses.

Your HOT POT can reach temperatures exceeding 500 degrees.

To state the obvious, we strongly recommend that you wear heat resistant (ie, leather) gloves at all times when handling the HOT POT™. FTI will not be liable for any burns which may result from either proper or improper use of the HOT POT™ food warmer.

WE STRONGLY RECOMMEND that you purchase a package of Reynolds brand oven bags from your grocery store. If you place all the pre-cooked food items you wish to heat in the oven bags and close either by using a twist tie or by rolling bag tightly closed you will avoid a messy cleanup.

Cooking times will vary as a result of both snow conditions and the terrain you're riding. On groomed trails warming will take longer because the engine won't be working as hard. If you want to accelerate cooking times either find some deeper snow to ride in or climb a hill a few times. This will cause the engine to work harder which will create more exhaust heat. (Sorry flatlanders, you'll just have to find a frozen lake and run at full throttle for a few minutes.....) HINT: Think FAST FOOD-the faster you go, the faster it cooks.

Following are a few examples of food items you can heat up in your HOT POT food warmer: Hot dogs, bratwurst or other sausage, fried chicken, pre-cooked omelettes, baked potatoes, burritos, spaghetti & meatballs, muffins, pre-baked trout or salmon filets, meatloaf, cheeseburger (pre-cooked), beef stew, hot pockets, pizza slices, and more. For dessert, try apple turnovers, pop-tarts or sticky buns.
